

# New Paths to CPA Proposed to Alleviate Accountant Shortage

Deloitte has joined KPMG in endorsing a proposed change in CPA licensure requirements allowing candidates to replace a fifth year of school with work experience. Companies, accounting firms, professional groups, and state accounting boards have been looking for ways to make the profession more appealing to students, as fewer students graduate with an accounting degree and more workers quit for higher paying, less stressful jobs. Many prospective accountants say they are daunted by the barrier to entry, including 150 college credit hours, which requires a Master's degree or additional college credits after a Bachelor's degree, to become a Certified Public Accountant.

## Corporate Tax Departments: Mergers & Acquisitions

- Atlanta packaging industry leader <u>Westrock</u> merged with European competitor <u>Smurfit Kappa</u> to create a new corporation called <u>Smurfit Westrock</u> (NYSE: SW), based in Dublin, Ireland.
- Another European packaging company, <u>DS Smith</u>, based in London with U.S. headquarters in Atlanta, received shareholder approval to be acquired by <u>International Paper</u> of Memphis.
- Tampa-based <u>Masonite International</u>, a leading designer, manufacturer and distributor of interior and exterior doors, was acquired by Toledo-based <u>Owens Corning</u> for \$3.9 billion.
- Orlando-based <u>Ruth's Chris Steakhouse</u>, a 97-year-old upscale chain with over 100 units, was acquired by <u>Darden Restaurants</u>, also based in Orlando, which added *Ruth's Chris* to its portfolio of Olive Garden, Longhorn, Capital Grille, Bahama Breeze, Chuy's and Seasons 52.
- Atlanta-based <u>NCR Corporation</u> completed its split into two separate NYSE companies, one for its ATM business and another for its software, consulting and technology businesses. The ATM division, branded as <u>NCR Atleos</u> (NYSE: NATL) has a tax team led by VP Vladimir Samoylenko; the services company, <u>NCR Voyix</u> (NYSE: VYX) is managed by Tax VP Rich McKenzie.
